4.1. Description of first aid measures

SECTION 5. Firefighting measures

5.1. Extinguishing media

Extinguishing media suitable for the surrounding fire should be used. Use water spray to cool containers.

5.2. Special hazards arising from the substance or mixture

When burned, it emits toxic fumes.

5.3. Advice for firefighters

GENERAL INFORMATION

Cool the containers with jets of water to avoid decomposition of the product and the development of substances potentially dangerous to health. Always wear full fire protection equipment. Collect extinguishing water that must not be discharged into sewers. Dispose of the contaminated water used for extinguishing and the residue of the fire according to current regulations.

EQUIPMENT

Normal clothing for fighting fire, such as an open circuit compressed air breathing apparatus (EN 137), flame retardant suit (EN469), flame retardant gloves (EN 659) and boots for firefighters (HO A29 or A30).

SECTION 6. Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Block the leakage if there is no hazard.

Wear suitable protective equipment (including personal protective equipment referred to under Section 8 of the safety data sheet) to prevent any contamination of skin, eyes and personal clothing. These indications apply for both processing staff and those involved in emergency procedures.

If outside, do not approach from downwind. If outside, keep bystanders upwind and away from the danger point. Delimit the contaminated area with signs and prevent access to unauthorized personnel. Turn leaking containers leaky side up to prevent liquid from spilling.

6.2. Environmental precautions

The product must not penetrate into the sewer system or come into contact with surface water or ground water.

6.3. Methods and material for containment and cleaning up

Collect the leaked product into a suitable container. Evaluate the compatibility of the container to be used, by checking section 10. Absorb the remainder with inert absorbent material.

Make sure the leakage site is well aired. Contaminated material should be disposed of in compliance with the provisions set forth in point 13.

Absorb in dry earth or sand. Transfer to a resealable, labeled waste container for disposal by an appropriate method.
