SECTION 4. First aid measures

4.1. Description of first aid measures

Skin contact: Immediately remove all contaminated clothing and footwear unless they are attached to the skin. Wash immediately with plenty of soap and water.

Eye contact: Flush eyes with running water for 15 minutes. Consult a doctor.

Ingestion: Rinse mouth with water. Consult a doctor.

Inhalation: Remove victim from exposure ensuring your safety while doing so. Consult a doctor.

Ingestion: Pain and redness of the mouth and throat may occur.

Inhalation: throat irritation with a feeling of tightness in the chest may occur. Exposure may cause coughing or wheezing.

Delayed/immediate effects: Immediate effects are to be expected after short-term exposure.

Cool the containers with jets of water to avoid decomposition of the product and the development of substances potentially dangerous to health. Always wear full fire protection equipment. EQUIPMENT

Block the leakage if there is no hazard.

If outside, do not approach from downwind. If outdoors, keep passers-by upwind and away from the danger point. Delimit the contaminated area with signs and prevent access to unauthorized personnel. Do not create dust.

6.3. Methods and material for containment and cleaning up

Collect the leaked product into a suitable container. Evaluate the compatibility of the container to be used, by checking section 10. Absorb the remainder with inert absorbent material.

Make sure the leakage site is well aired. Contaminated material should be disposed of in compliance with the provisions set forth in point 13.

Transfer to a labeled airtight recovery container and discard appropriately.
