## SECTION 4. First aid measures

## 4.1. Description of first aid measures

Contact with eyes: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check and remove any contact lenses. Continue rinsing for at least 10 minutes. Consult a doctor.

Inhalation: Remove the victim to fresh air and keep him at rest in a position comfortable for breathing.

If he is not breathing, if breathing is irregular, or if respiratory arrest occurs, take action artificial respiration or oxygen by qualified personnel. Mouth-to-mouth resuscitation can be dangerous for the person providing aid. Seek medical attention if adverse health effects persist or are severe. In case of loss of consciousness, place in recovery position and contact a doctor immediately. Keep the airway open. Loosen tight clothing such as a collar, tie, belt or belt.

Skin contact: Wash thoroughly with soap and water. Remove contaminated clothing and shoes.

amounts of water to drink. Stop if the exposed person feels sick because vomiting can be dangerous. Do not induce vomiting unless directed by medical personnel. If vomiting occurs, the head should be kept low so that the vomit does not enter the lungs. Seek medical attention if adverse health effects persist or are severe. Never give anything by mouth to an unconscious person. If she is unconscious, place her in the recovery position and seek medical attention immediately.

Keep the airway open. Loosen tight clothing such as collar, tie, belt or waist.

**5.3. Advice for firefighters**

## 7.1. Precautions for safe handling

## 8.2. Exposure controls
